



## We look forward to welcoming you onboard. Please take a few minutes and familiarize yourself with the latest published requirements for travel.

It is very important to verify the necessary documents for: travel with your airline, entry into the country of your destination, and your cruise with us. Be aware that requirements are most likely different in all cases and we encourage you to check them frequently before departing for the airport, as restrictions and documentation requirements for travel to various countries within the European Union during COVID-19 are still fluid and may change.

### 1. INTERNATIONAL TRAVEL TO YOUR AMADEUS CRUISE DESTINATION

As countries are opening to U.S. leisure travelers, governmental requirements *can and may change*. As always, for the most up-to-date and accurate information:

### 2. EMBARKATION AND CHECK-IN FOR YOUR AMADEUS CRUISE

In order to embark our vessels, all passengers must be: fully vaccinated or provide documentation of recovery from COVID-19. Due to the current official regulations, passengers may only board the ship if they are able to present proof of the following:

#### EITHER

- **Fully vaccinated:** guests with an EMA (European Medicines Agency) approved vaccine are required to have a 3rd shot (booster) if the second shot was more than 270 days ago

#### OR

- **Recovery from COVID-19:** evidence includes a quarantine certificate or proof of at least 11 day, max. 180 days old positive PCR-RT test

*Proof must be presented **before** boarding the vessel. Exceptions are not possible. Please note that the measures are subject to change and restrictions might be eased. We ask you to check with your travel agent before starting your trip.*

#### FULLY VACCINATED

Fully vaccinated means guests have received a vaccine\* approved by the EMA (European Medicines Agency) the second shot has been completed at least 14 days prior to embarkation (28 days for the Johnson & Johnson vaccine). Please bring with you the original government issued verification of your vaccination record.

All passengers must also complete and submit our Health Declaration form, which is mandatory for all guests, at the time of embarkation.

Any Individual who reports having or is observed to have any COVID-19 symptoms, or who has recently been in contact with anyone who has tested positive for COVID-19 or is symptomatic, will not be allowed to board our vessels.

### 3. DURING YOUR CRUISE WITH US

Should local authorities request any additional testing, the staff onboard will facilitate the process for our guests.

### 4. RETURNING BACK TO YOUR COUNTRY

If you are departing on your international flight directly after disembarkation, and a COVID-19 test is required, the staff onboard will facilitate the arrangement for testing. Please notify the staff onboard of your request.

**Passengers must show proof of their vaccination status. Copies or pictures of documentation are not valid. This requirement applies to ALL passengers.**

\*Current EMA approved vaccines are: BioNtech/Pfizer, Astra Zeneca, Covishield, Covaxin, Covovax, Johnson & Johnson, Moderna, Nuvaxovid (Novavax).

Please note that health protocols are subject to change and may be updated at any time or even during your cruise. You will be advised upon embarkation and/or during the cruise as appropriate.
